(1) Funding source for LMR specific operations: AMIO and CD operations continue to take precedence over LMR activities during normal cutter operations on the West Coast of Puerto Rico. Surging small boat resources from Station San Juan would be the ideal way to protect species covered under the endangered species act during periods of increased vulnerability. Local marine biologist Michelle T. Schärer-Umpierre, PhD and NOAA agent Miguel Borges provide fish-based intelligence on these time windows, but this can rarely be acted on with good effects without the ability to dedicate resources specifically to LMR.
