

JOINT ENFORCEMENT

- Maritime patrol aboard a CBP vessel to detect illegal foreign fishing and smuggling in Puerto Rico and USVI AOR.
- CBP AMO response
- Joint maritime patrol with CBP AMO in the Red Hook area.
- Future joint operations are planned to conduct enforcement and surveillance.



NOAA Fisheries released the Office of Law Enforcement's Draft Enforcement Priorities for 2023-20






